### GUARANTEED ADMISSION

**JUNE 1<sup>ST</sup>** - register and submit **\$75 non-refundable** deposit to secure your child's spot in camp (late registration subject to availability)

**REFUND POLICY:** In order for us to provide a quality experience for your camper, please note the following refund policy if your camper is unable to attend for any reason:

- Written notice of a refund request received more than 14 days before the first day of camp: you will receive a refund of tuition less your non-refundable deposit and fees.
- Written notice received 1-14 days before the first day of camp: you will receive a 50% refund of tuition less your non-refundable deposit and fees.
- No refund is available after camp has begun.

**EARLY ENROLLMENT DEDUCTION:** Enroll by May 31, 2018 (paid in full) to receive a 10% deduction on enrollment fees.

**MULTIPLE SIBLING DISCOUNT** Each additional sibling in a home receives a \$25 discount on enrollment fee.
